

Fishing tournament permit application instructions

Please fill out all required fields (in bold) on the Fishing Tournament Permit Application including either your DNR customer number (found on any fishing or hunting license) or a social security number. Before the application can be reviewed an application fee must be received by the department. The application fee varies depending on the type of tournament and the amount of prizes to be awarded; see table below for details.

Application Fee Structure

Tournament type	Prize value	Application fee
Immediate release	Any	\$25
Great Lakes salmon or trout	Any	\$25
Rough fish	Any	\$25
Any	<\$1,000	\$25
“Catch-hold-release” or “catch and keep”	\$1,000 - \$9,999	\$50
“Catch-hold-release” or “catch and keep”	>10,000	\$200

What Happens Next?

- Once the application and fee are received, a fisheries biologist will review it;
- If approved, the biologist will mail you a signed permit with conditions for the tournament and a blank tournament results form;
- The results form must be filled out and returned to the address above within 30 days after the tournament is held.
